WHEREAS, the 2019-Novel Coronavirus (COVID-19) is an infection associated with fever and signs and symptoms of pneumonia or other respiratory illness, appears to be transmitted from person to person predominately through droplet transmission and, if spread in the population, could have significant public health consequences; and

WHEREAS, on February 1, 2020, pursuant to 10 NYCRR Section 2.1(a), Dr. Howard A. Zucker, as Commissioner of Health of the State of New York, designated COVID-19 as a communicable disease under the State Sanitary Code, which was ratified on February 6, 2020, through the adoption of emergency regulations amending 10 NYCRR Section 2.1; and

WHEREAS, on March 7, 2020, Governor Andrew Cuomo declared a State of Emergency throughout New York State; and

WHEREAS, on March 11, 2020, the World Health Organization declared the COVID-19 outbreak a pandemic; and

WHEREAS, there are several confirmed cases of COVID-19 in Saratoga County and that number is increasing; and

WHEREAS the City of Mechanicville has a clear governmental interest in protecting the health and safety of the residents of the City and beyond; and WHEREAS, pursuant to §24 of the Executive Law of the State of New York, in the event of a disaster and a similar public emergency, and upon a finding that public safety is imperiled by said disaster and/or similar public emergency, or in the event of a reasonable apprehension of immediate danger thereof, the Mayor may proclaim a local State of Emergency and issue Emergency Orders, within any part of all of the territorial limits of such local government; and WHEREAS, pursuant to §24 of the Executive Law of the State of New York, such proclamation of a Local State of Emergency shall remain in effect for up to thirty (30) days, but may be extended for additional periods, not to exceed (30) days each during the pendency of the disaster and similar public emergency;


NOW, THEREFORE, I Dennis Baker, Mayor of the City of Mechanicville, in accordance with the aforementioned and in furtherance of my statutory duties, do hereby Order and direct as follows:

IT IS HEREBY DETERMINED, that the public safety of the citizens of the City of Mechanicville is imperiled by COVID-19; and

IT IS FURTHER ORDERED, that a State of Emergency is declared and exists in the City of Mechanicville and is effective at 4:00 pm on May 15, 2020; and

IT IS FURTHER HEREBY ORDERED, this Order shall remain in effect for thirty (30) days unless sooner rescinded or modified by me as Mayor of the City of Mechanicville, but may be extended for additional periods not to exceed thirty (30) days each during the pendency of this disaster and similar public emergency.



STATE OF EMERGENCY DECLARATION

A State of Emergency is hereby declared in the City of Mechanicville effective 4:00PM on May 15, 2020. This State of Emergency has been directed due to the outbreak designated by the World Health Organization as the novel coronavirus, COVID-19, and the impact the outbreak may have on our community. I hereby find that public safety is imperiled by the outbreak.

This State of Emergency will remain in effect for a period of thirty (30) days, unless extended or rescinded.

As the Chief Executive of the City of Mechanicville, I, Dennis Baker, exercise the authority given me pursuant § 24 of the New York State Executive Law, to preserve the public safety and hereby render all required assistance vital to the security, well-being, and health of the citizens of the City of Mechanicville. I hereby direct all departments and agencies of the City of Mechanicville to take whatever steps necessary to protect life and property, public infrastructure, and provide emergency assistance as deemed necessary.
